 - It has been provided under ordinance 5.1 (b) & (c) that "all admitted candidates shall undergo a course-work for a minimum period of one semester of six months as prescribed by the University."



3 Ordinance 6.03 provides for the course work to be treated as Pre-Ph.D preparation; Ordinance 6.04 provides for preparation of the time-table for the course-work, continuation of evaluation and internal tests; Ordinance 4.2 provides for 75% minimum attendance of all class lectures and Ordinance 6.06 provides for conduct of a semester end qualifying examination.

4 The Ph.D program of the University is a regular program and the Course-Work is essentially a regular course for which the candidates are required to attend the classes at the rate 75 percent.

5 Since 75 percent attendance in course work is mandatory, the candidates employed in service of Government/ Semi-Government/ Educational Institute/ Defense/ Corporations etc. are required to submit Leave-Granted-Certificates duly issued by their respective Employers.
